JONATHAN HEALY *Healy Communications* has worked in radio, television and online media for over two decades. He has been a presenter with Newstalk 106-108fm and a correspondent with Sky News, with his work featuring prominently on both stations. Jonathan also has experience working with TV3, RTE, FM104, and Cork's RedFM. Having conducted thousands of interviews with people from all works of Irish life, he is a skilled interviewer and is now bring this experience to PR and media training through his own company, Healy Communications.



PETER ORMOND *Cathaoirleach, Offaly County Council* was first elected in 1999. Peter graduated with a Degree in Business Administration and has served on many boards at both local and national level. He has extensive experience in community development and is currently working on the Rural Development Programme in Westmeath Community Development. DR. TARA SHINE *Environmental Scientist and Director, Change by Degrees* is passionate about changing the conversation on climate change and sustainability. She is an environmental scientist with over 20 years' experience working as an adviser to governments and world leaders, as a negotiator and a researcher. Tara is taking this experience of shaping policy at the global level to drive change in her own community and country. In 2018 she co-founded the social enterprise Change by Degrees and the community initiative Plastic Free Kinsale. Using both of these platforms she informs and empowers people at home and at work to live more sustainably. Tara presents wildlife and nature documentaries for RTE and the BBC. She was the first woman living in Ireland to take part in Homeward Bound, a global leadership programme for women in science, which involved an expedition to Antarctica in January 2019.

Recent projects included work in the areas of Sustainability, Data Ethics, Ethical Leadership, Responsible Management & Organisational Learning & Change. Origin Enterprises Plc and Science Foundation Ireland. This is one of Europe's largest university-based research programmes on 'big data' applied to field-scale crop production (www.consus.ie). He has a particular interest in the application of IoT and 'precision agriculture' technology to enhance the operational efficiency of agri-food systems, from on-farm operations right through to the consumer, including the implementation of a 'circular economy' in agriculture.
